## OUR STUDENTS

As the doors open to schools for the fall of 2007, over 900 elementary students will be starting their school year in a different facility as the result of the new boundaries for elementary attendance.

Timber Ridge Elementary opened its doors for the first time. This new elementary is located at the corner of 72nd St. and 54th Ave.

The middle school will provide students with a new cafeteria, LMC, administrative offices and a few remodeled classrooms.

Construction on the high school renovation project has started and will continue throughout the 2007-2008 school year.

Infinite Campus will be the new student information software utilized by the district. Parents will also have access to their child's information in grades 6 through 12 by September 25, 2007.

The board will continue to focus on their eight goal areas of communications, school improvement, curriculum and instruction, facilities, personnel, professional development, business and finance, and activities.

An in-depth review of district finances in regards to departments, divisions, and buildings will be completed to continue to keep the district in good financial condition. This review includes a study of transportation services provided to students.

The ACT is the usual college entrance exam taken by students who intend to go to college. A score of 20 or higher on the 36-point scale for the test indicates probable success in college.

District goals are based upon all students who take the assessments. The goals were as follows:

The percentage of students at the proficient or higher levels in reading will reach or exceed **93.5%** at 4th grade; **88.3%** at 8th; and **91.6%** at 11th on 2006 ITBS/ITED. The district did not meet these goals. Actual results were **92.1%** at 4th grade; **81.6%** at 8th; and **81.3%** at 11th.

The percentage of students at the proficient or higher levels in math will reach or exceed **92.8%** at 4th grade; **91.4%** at 8th; and **92.6%** at 11th on 2006 ITBS/ITED. The district did not meet these goals. Actual results were **92.7%** at 4th grade; **85%** at 8th; and **88.9%** at 11th.

The percentage of students at the proficient or higher levels in science will reach or exceed **91%** at 8th; and **91.2%** at 11th on 2006 ITBS/ITED. The district did not meet these goals. Actual results were **88.3%** at 8th; and **87.6%** at 11th.

Building staff analyze student data to determine strengths in our curriculum and areas where more strategies and focus need to be given.
