Enrollment for Hawki and Medicaid is open year-round. Your child could be approved for **immediate coverage** through the Presumptive Eligibility Medicaid application process offered at EveryStep. Call to schedule an appointment if the following applies:

- If your child is uninsured or *underinsured*.
- If you are paying too much for your child's health insurance.
- If your family income falls within the income guidelines.



Hawki offers free or low-cost health insurance for kids and teens. Many working families qualify — even a family of four, making up to \$80,030 per year!

Requirements:

- Children must be under age 19
- Cannot be dually enrolled with other health insurance*
- Children must be U.S. citizens or have a qualifying immigration status
- Must meet Hawki family income guidelines below

**Even if your child already has medical or dental coverage, you can still get dental coverage through Hawki. Dental coverage is provided by Delta Dental of Iowa. Should you meet all eligibility requirements after applying, your child will automatically be put on Hawki Dental Only. Once Hawki Dental Only is established, you have the option of canceling your private health insurance coverage and upgrading to full Hawki coverage.*
